> Can the Tribute Trust help you?

> Filling in the application form

- Please do not forget to sign the declaration at the end. If you do not sign it we cannot assess your application.

- If we are able to help you with a grant, we will write to tell you, and to arrange how we will pay the award.
- If we are unable to help you with any kind of payment, we will write to tell you. Please note that the Tottenham Tribute Trust cannot disclose the particular reasons why a grant is not awarded.
- It may take several weeks to process your application. If you are concerned at any apparent delay please write to the address given above to find out which stage of the assessment process your application is in.

> Applying to the Tottenham Tribute Trust again

- If you receive a grant award from the Tottenham Tribute Trust, you cannot apply again for 2 years.
- If you do not receive a grant award from the Tottenham Tribute Trust, you can apply again after 6 months.
